Further, seeking to understand unique perspectives helps inspire fresh angles of inquiry, new discoveries and find innovative solutions to today's challenges.

While we are proud that equity drives much of our educational platform, we also recognize that now, more than ever, it is incumbent on us to listen to and elevate the voices, experiences, and history of our fellow students and communities – particularly those that are not always represented, or represented fairly, in an educational setting. As teachers and students, we recognize that we must engage intellectually with the changes that result from current events.
