STANDARDS FOR VISUAL ARTS GRADE 7

Visual art classes at the middle grades emphasize the exploration of studio processes. At seventh grade, students engage in the creative process and continue to develop the strategies, skills, and practices of art. They apply the elements of art and the principles of design to solve design problems, using traditional and contemporary art media. Visual literacy, critical thinking, and problem solving are important components of the artmaking process. Students critique works of art, reflecting on and assessing the characteristics and merits of personal work and the artwork of others. Students understand the role of visual art in shaping historical and cultural traditions, and how history and culture have influenced art.

CREATING (Investigate – Plan – Make) Conceiving and developing new artistic ideas and work

CREATING (Investigate)

Conceiving and developing new artistic ideas and work

CREATING (Reflect – Refine – Continue) Conceiving and developing new artistic ideas and work

PRESENTING (Select – Analyze – Share) Interpreting and sharing artistic work

RESPONDING (Perceive – Analyze – Interpret) Understanding and evaluating how the arts convey meaning

VA.Re1.2.7 Analyze multiple ways that images influence specific audiences (for example: flags at the opening ceremony of the Olympic Games, athletic logos at sporting events, costumes at a sci-fi convention, etc.).
